TWO DIE IN MOTOR VEHICLE ACCIDENT AT GEITA GOLD MINE

AngloGold Ashanti regrets to announce the death of two workers in a motor vehicle accident that occurred early in the morning of Wednesday, 12 May 2010.

The accident occurred when a Terex dump truck hauling waste onto a waste dump struck the rear of a stationary truck, and continued rolling, crushing a stationary light vehicle parked nearby.

Honest Ngowi, the operator of the moving vehicle, and Esau Mwakibuja, a mechanic in the stationary light vehicle, were fatally injured.

Mr Ngowi, a 27-year-old man from Kilimanjaro, Tanzania, had been employed by Geita for three years.

Mr Mwakibuja was a 40-year-old Terex employee based at Geita from Mbeya, Tanzania.

Mining operations have been suspended to allow for a full investigation into the causes of the accident. Normal operations are expected to resume from Friday.

AngloGold Ashanti and Geita management offer their sincere condolences and support to the family and friends of the deceased.
