### Fatal accident at Kopanang

AngloGold Ashanti regrets to announce the death of a stope driller in a fall of ground accident yesterday afternoon at the Kopanang Mine near Klerksdorp, about 180km south west of Johannesburg. The man's name cannot yet be released as his next-of-kin have not yet been informed.

The accident took place about 2,000 metres underground.

All blasting at the mine has been suspended pending an in loco inspection this morning by the Department of Minerals and Energy.
