### FATALITY AT MOAB KHOTSONG

AngloGold Ashanti regrets to announce the death of Patrick Sinono, a Miner's Assistant at Moab Khotsong mine, near Klerksdorp. Mr Sinono was barring at a stope face on 88 level when he was fatally injured in a fall of ground incident. The incident took place at approximately 07h00 this morning. No other employees were injured in the incident.

AngloGold Ashanti would like to extend its condolences to Mr Sinono's family and friends as well as to the community at Moab Khotsong. Mr Sinono leaves a wife, Nosandiso, and four children, who live in Qombolo Village, near Kentani in the Eastern Cape.
