AngloGold Ashanti regrets to announce the death earlier today of Mr Ramakhaola, a stope driller at its Moab Khotsong mine in the Free State, South Africa. Mr Ramakhaola was fatally injured whilst carrying out his duties at a working face some 2,277m below surface.

AngloGold Ashanti would like to extend its condolences to Mr Ramakhaola's family and friends. Mr Ramakhaola was from Lesotho and leaves behind his wife Matankiso and their two children Neo and Tankiso.

No other employees were injured in the course of the accident.
