Accordingly, SepHold, Métier Mixed Concrete (Pty) Ltd ("Métier" or "the subsidiary") and Dangote Cement SA (Pty) Ltd ("SepCem" or "the associate"), collectively referred to as "the group", advises shareholders that, the basic earnings per share ("BEPS") and headline earnings per share ("HEPS") for the six months ended 30 September 2023 compared to the six months ended 30 September 2022 ("H1 2023") are expected to decrease as follows:

- the BEPS to be between 7.12 cents and 7.96 cents representing a decrease of between 24% and 32% (H1 2023: BEPS at 10.51 cents), and
- the HEPS to be between 7.31 cents and 8.21 cents representing a decrease of between 27% and 35% (H1 2023: HEPS at 11.26 cents).

SepCem has a December year-end as a subsidiary of Dangote Cement PLC, therefore the associate's figures incorporated in the interim results refer to the six months ended 30 June 2023.

The financial information on which this trading statement is based, has not been reviewed or reported on by the Company's external auditors.
