2) In Rand to shareholders on the SA branch register calculated at the Rand to US dollar exchange rate on Friday 2 July 2004, which rate will be announced on that day and

3) In dollars to all other overseas shareholders (unless they elect to receive Sterling dividends or have mandated their dividends to a UK bank or participate in TAPS – see below).

Elections to receive an alternative currency (dollars or sterling) should comprise a signed request to Lloyds TSB Registrars to be received by 1700 hours on Friday 16 July 2004.
