## 1. DEFINITIONS

Client	Any natural or juristic person that received or receives services from the Company or any of its subsidiaries.
Conditions for Lawful Processing	The conditions for the lawful processing of Personal Information as fully set out in chapter 3 of POPI and in paragraph 12 of this Manual.
Data Subject	The person to whom Personal Information relates.
Information Officer	The individual who is identified in paragraph 3 of this manual.
Manual	This manual.
PAIA	The Promotion of Access to Information Act 2 of 2000.
Personal Information	Means information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person, including, but not limited to – <ul style="list-style-type: none"> <li>a. Information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, Colour, sexual orientation, age, physical or mental health, well-being, disability, religion, conscience, belief, culture, language and birth of the person;</li> <li>b. Information relating to the education or the medical, financial, criminal or employment history of the person;</li> <li>c. Any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier or other particular assignment to the person;</li> </ul>

- d. The biometric information of the person;
- e. The personal opinions, views or preferences of the person;
- f. Correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence;
- g. The views or opinions of another individual about the person; and
- h. The name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person.

Personnel

Any person who works for or provides services to or on behalf of the Company and receives or is entitled to receive remuneration and any other person who assists in carrying out or conducting the business of the Company, which includes, without limitation, directors (executive and non-executive), all permanent, temporary and part-time staff as well as contract workers.

POPI

The Protection of Personal Information Act 4 of 2013.

POPI Regulations

The regulations promulgated in terms of section 112(2) of POPI.

Private Body

Means –

- a. A natural person who carries or has carried on any trade, business or profession, but only in such capacity;
- b. A partnership which carries or has carried on any trade, business or profession; or

- c. Any former or existing juristic person, but excludes a public body.

Processing

Means any operation or activity or any set of operations, whether or not by automatic means, concerning personal information, including –

- a. The collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval, alteration, consultation or use;
- b. Dissemination by means of transmission, distribution or making available in any other form; or
- c. Merging, linking, as well as restriction, degradation, erasure or destruction of information.

SAHRC

The South African Human Rights Commission.

Any other terms not described herein will have the meaning as ascribed to it in terms of PAIA or POPI.

## 2. INTRODUCTION

- 2.1. This Manual is articulated in conformity with the laws and statutory provisions of the Republic of South Africa, and in consideration of pertinent international privacy laws and standards. This Manual is applicable to the Company and which for the purpose of the Protection of Personal Information Act 4 of 2013 and the Promotion of Access to Information Act 2 of 2000, is defined as a private body.
- 2.2. The Promotion of Access to Information Act, 2000 was implemented on 9 March 2001. It grants individuals and legal entities the right to access records held by public or private bodies, with certain limitations, to facilitate the exercise or protection of their rights.
- 2.3. The Promotion of Access to Information Act 2 of 2000 establishes the procedural aspects related to information requests, which include the requirement to create a Promotion of Access to Information Act 2 of 2000 Manual (also referred to as a “PAIA Manual”). Private bodies are mandated by Section 51 of the Promotion of Access to Information Act 2 of 2000 to compile a

Manual that allows individuals to access information held. The Manual specifies the minimum criteria that must be met.

- 2.4. If you wish to obtain information from a private body under the Promotion of Access to Information Act 2 of 2000, a request must be made in the prescribed format outlined in the private body's Promotion of Access to Information Act 2 of 2000 Manual, just like ours. Once the request is received, the private body must disclose the information if the requester can demonstrate that the record is necessary for exercising or protecting their rights, provided that no grounds for refusal stated in the Promotion of Access to Information Act 2 of 2000 are applicable.
- 2.5. Ultimately, your privacy is very important to us, and the Company and its Subsidiaries is committed to protecting your right to privacy as well as your right to access any information that we have on you.

### **3. THE PROMOTION OF ACCESS TO INFORMATION ACT 2 OF 2000 MANUAL**

- 3.1. This Manual serves as the Company's Promotion of Access to Information Act 2 of 2000 Manual, complying with section 51 of the Promotion of Access to Information Act 2 of 2000 as amended by the Protection of Personal Information Act 4 of 2013.
- 3.2. The Protection of Personal Information Act 4 of 2013, which primarily came into effect on 1 July 2020, upholds individuals' Constitutional right to privacy and emphasizes the protection of personal information handled by public and private entities within the Republic of South Africa. It establishes specific conditions to establish minimum requirements for the handling of personal information.
- 3.3. The Protection of Personal Information Act 4 of 2013, amends certain provisions of the Promotion of Access to Information Act 2 of 2000, striking a balance between the need for information access and the necessity to safeguard personal information. It establishes an Information Regulator with certain powers, duties, and functions under both The Protection of Personal Information Act 4 of 2013 and the Promotion of Access to Information Act 2 of 2000. Additionally, it introduces codes of conduct and safeguards individuals' rights concerning unsolicited electronic communications and automated decision-making processes. The aim is to regulate the flow of personal information and address related matters.
- 3.4. We have compiled this Manual to provide you with guidance and ensure that you understand the procedural and other requirements that must be fulfilled when making a Promotion of Access to Information Act 2 of 2000 request (also known as a "PAIA Request") to the Company or its subsidiaries

If a Requester believes that a right of access to a record exists in terms of other legislation listed above or any other legislation, the Requester is required to indicate what legislative right the request is based on, to allow the Information Officer the opportunity of considering the request in light thereof.*

## **10. REQUEST PROCESS**

- 10.1. An individual who wishes to place a request must comply with all the procedures laid down in PAIA.
- 10.2. The requester must complete **ANNEXURE B**, which is attached hereto and submit it to the Information Officer at the details specified above.
- 10.3. The prescribed form must be submitted as well as payment of a request fee and a deposit, if applicable to the information officer at the postal or physical address, fax number or electronic mail as is stated herein.

- 10.4. The prescribed form must be completed with enough particularity to enable the information officer to determine:
- 10.4.1. The record(s) requested;
  - 10.4.2. The identity of the requestor;
  - 10.4.3. What form of access is required; and
  - 10.4.4. The Postal address or fax number of the requestor.
- 10.5. The requestor must state that the records are required for the requestor to exercise or protect a right, and clearly state what the nature of the right is so to be exercised or protected. An explanation of why the records requested is required to exercise or protect the right.
- 10.6. The request for access will be dealt with within 30 days from date of receipt, unless the requestor has set out special grounds that satisfies the Information Officer that the request be dealt with sooner.
- 10.7. The period of 30 days may be extended by not more than 30 additional days, if the request is for a large quantity of information, or the request requires a search for information held at another office of the Company and the information cannot be reasonably obtained within 30 days. The information officer will notify the requestor in writing should an extension be necessary.
- 10.8. The Information Officer must communicate a response to the request for access using “**Annexure E**”, this communication shall inform the requestor of:
- 10.8.1. The decision;
  - 10.8.2. Fees payable in terms of paragraph 13.
- 10.9. In the event that the Information Officer is of the opinion that the searching and preparation of the record for disclosure would amount to more than 6 hours, he/she shall inform the requestor to pay a deposit not exceeding one third of the amount payable.
- 10.10. Should the requestor have any difficulty with the form or the process laid out herein, the requestor should contact the Information Officer for assistance.
- 10.11. An oral request can be made to the Information Officer should the requestor be unable to complete the form due to illiteracy or a disability. The Information Officer will complete the form on behalf of the requestor and provide a copy of the form to the requestor.

## 11. **GROUNDINGS FOR REFUSAL**

- 11.1. The following are grounds upon which the Company may, subject to the exceptions in Chapter 4 of PAIA, refuse a request for access in accordance with Chapter 4 of PAIA:

- 11.1.1. Mandatory protection of the privacy of a third party who is a natural person, including a deceased person, where such disclosure of Personal Information would be unreasonable.
- 11.1.2. Mandatory protection of the commercial information of a third party, if the Records contain:
  - 11.1.2.1. Trade secrets of that third party;
  - 11.1.2.2. Financial, commercial, scientific or technical information of the third party, the disclosure of which could likely cause harm to the financial or commercial interests of that third party; and/or
  - 11.1.2.3. Information disclosed in confidence by a third party to The Company, the disclosure of which could put that third party at a disadvantage in contractual or other negotiations or prejudice the third party in commercial competition;
- 11.1.3. Mandatory protection of confidential information of third parties if it is protected in terms of any agreement;
- 11.1.4. Mandatory protection of the safety of individuals and the protection of property;
- 11.1.5. Mandatory protection of Records that would be regarded as privileged in legal proceedings;
- 11.1.6. Protection of the commercial information of the Company, which may include:
  - 11.1.6.1. Trade secrets;
  - 11.1.6.2. Financial/commercial, scientific or technical information, the disclosure of which could likely cause harm to the financial or commercial interests of the Company;
  - 11.1.6.3. Information which, if disclosed, could put the Company at a disadvantage in contractual or other negotiations or prejudice the Company in commercial competition; and/or
  - 11.1.6.4. Computer programs which are owned by the Company, and which are protected by copyright and intellectual property laws;
- 11.1.7. Research information of the Company or a third party, if such disclosure would place the research or the researcher at a serious disadvantage; and
- 11.1.8. Requests for Records that are clearly frivolous or vexatious, or which involve an unreasonable diversion of resources.

## **12. REMEDIES SHOULD A REQUEST BE REFUSED**

- 12.1. The Company does not have an internal appeal procedure in light of a denial of a request, decisions made by the information officer is final.
- 12.2. The requestor may in accordance with sections 56(3) © and 78 of PAIA, apply to a court for relief within 180 days of notification of the decision for appropriate relief.

- 14.1.3.4. the purposes related to any authorised disclosure made in terms of agreement, law or regulation;
- 14.1.3.5. any additional purposes expressly authorised by the Company's client;
- 14.1.3.6. any additional purposes as may be notified to the Client or Data Subjects in any notice provided by the Company.

  - 14.7.2. Such physical data records will be 'locked-away' and secured when not in use.
- 14.8. The Company may share personal information with third parties and in certain instances this may result in cross border flow of the personal information. The personal information will always be subject to protection, not less than the protection it is afforded under the Protection of Personal Information Act No.4 of 2013.
- 14.9. Objection to the processing of personal information by a data subject:
- 14.9.1. Section 11(3) of POPI and regulation 2 of the POPI regulations provides that a data subject may, at any time object to the processing of their personal information in the prescribed form attached to this manual as **ANNEXURE "C"**.
